



## **SAFEGUARDING/CHILD PROTECTION** **Permission for Photographs/Recordings/Images/Video**

Omagh Integrated Primary School and Nursery regularly takes photographs of children to use as evidence of learning and progress. These photographs may be displayed in the classroom, the cloakroom, in books, in the main entrance area, in the dinner hall or during presentations. The school is very aware of the concerns around the use of digital media of children and in an attempt to comply with the Data Protection legislation and our own Child Protection Policy we need your permission before we take and display any photographs/videos and recordings of your child/ren.

As Omagh Integrated Primary School and Nursery Unit is also a valued member of our local community, our achievements and successes have been celebrated in the local and national press. We must also seek permission from you to publish photographs/images of your child in newspapers. We also need to seek your permission before any school activities can be recorded on various formats by staff.

We anticipate that information about the activities and achievements within our school will be published on the school's website and other school related websites (see below). Again in keeping with current GDPR and Child Protection legislation, we must seek your permission to display photographs/images and recordings of activities and achievements.

We use photographic/video observations in Nursery to record children's play and involvement- some of these will be included in your child's work folder. Throughout the Nursery year we may often send home some of these photographs however some of these photos may feature other children and therefore we require your consent if you allow photographs which your child may feature in to be added to another child's folder or sent home. All photographs/images sent home are for your own use and **must not** be shared on social networking sites.
